A receipt of recent rent payment (not more than **30 days** old) must accompany this declaration. Payment receipt must show the date, name and address of the occupant. Please see the reverse side of this document for a list of additional documents required for verification of residency.

*You can demonstrate that you live in the Meriden Public School District by providing Central Registration with ONE item from EACH of the two categories below. All items must be less than 60 days old and reflect the current address.* 

## Accepted Forms Of Proof Of Residency

Please note that we do not accept hand written notes or state benefit letters.

We require ONE document from the following AND ONE document from the following Category A Category B

Note: We cannot accept self-addressed envelopes, "Shut Off" notices or "junk mail" If you do not have two items from the categories above, we will work with you to find acceptable documents to establish residency.
